

Objects and Functions

1. Objects and functions [Sections 5(1)(a), 5(1)(b) of MSCS Act, 2002]:

(a) Objects:

The principal object of the society will be to promote the interests of all its Members, present in the states **Uttar Pradesh and Haryana** to attain their social and economic betterment through self-help and mutual aid in accordance with the cooperative principles. The detailed objects shall be as follows:

In furtherance of the above objective the society may undertake any or all of the following activities:-

1. To carry on the business of purchase, sale deal trade in any agriculture products, agriculture related products such as fertilizers, seeds, pesticides, animal food cattle feed, dairy business etc.
2. To Undertake manufacture, produce, process, grading, packing, purchase, sale, import, export and supply of pesticides, agricultural products, all crops, cultivate marketing and processing requisites, such as manure, grain, pulses, cereal, seeds, fertilizer, agricultural implements and machinery, packing machinery, processing machinery for agriculture commodities, forest produce, fishery, dairy, poultry, wool and other animal products and to develop an e- commerce site to be used as a basic marketing technical assistance and marketing tool and to procure all crops from farmers for and on behalf of the central and state governments and their departments and agencies like FCI, PCF, RFC, ITC, Britannia, Adani, PCU, Zafed, Nafed, Nccf, Hafed, Iffco, Kribhco, IPL, RFC and all type pesticides and fertilizer company/ Govt. Department AND Other departments etc.
3. To help the members to avail the benefits of any schemes launched by the state or central government for promotion of agriculture.
4. To implement any state or central government schemes related to agriculture for the betterment of the members.
5. To conduct sessions for providing technical knowledge, training etc. to its members to make them improve their production in agriculture.
6. To help the members to avail the facilities of cooperative stores, dealing in agro products and to implement state or Central Govt.schemes.

7. To help the members in getting better revenue of their production by conducting market surveys and to provide godowns, warehousing and cold storage facilities to its members.
8. To provide Minimum Support Price (MSP) for food grains and other agricultural products of its members under price support scheme directly as the state agency or with the association of any other agency nominated by State or Central Government for this purpose.
9. To open mobile purchase centers, extension centres within the area of operation of the society or at such other places with the permission of the competent authorities wherever required with the prior approval of the Central Registrar.
10. To subscribe and / or become a member of or otherwise cooperate in any manner with any cooperative association having objects altogether or in part similar to those of society.
11. To take all necessary steps for creating, acquiring and / or protecting one's own brand, logo and brand name.
12. To do all such other things as are incidental and conducive to the promotion or advancement of these objects and of the business of the society.

(b) Functions :

In furtherance of the above objects, the society may undertake any or all the following activities (to be specified as per the objects of the society):

- (a) To do all such incidental activities for attainment of main objects of the society.
- (b) The society shall not indulge in any credit/ deposit related functions.
